Dear PSSAM Members:

Last night we were horrified to learn that Calvert County Superintendent Daniel D. Curry was named 'Superintendent of the Year' by the PSSAM. While we appreciate the irony that such an honor was bestowed on Halloween to a "man" as evil and malicious as he, it is undeserved. Our family is currently suing Calvert County Public Schools for violations of the Public Information Act, and we will be suing again after we finally receive thousands of missing emails and numerous financial records for which we paid exorbitant sums of money. While this letter may sound outrageous, everything we are saying is true and we would hate for anyone to have a favorable impression of Daniel D. Curry or facilitate his abuse of people through any means because they mistakenly believe he is caring and competent. He is neither.

Daniel D. Curry, and before him, Superintendent Jack Smith (now of Montgomery County) have run CCPS into the ground. Both have operated with complete malice against caring educators, students and families, and our suits will expose a variety of mental, emotional, physical, sexual, and financial abuses. We are accusing Daniel D. Curry of committing, encouraging and/or covering up all of these. This is a ragingly narcissistic and predatory man who thrills to pain, and who will retaliate against anyone who questions his behavior and actions. For example, when we sent in a complaint to Curry and the Board, he ordered further abuse of our daughter, and then retaliation against our sons because he could not get to us. We removed them from CCPS and they are now in private school, where they are safe and supported; however, employees and students in CCPS are still not safe. Daniel D. Curry has even invited a school shooting to serve as a dramatic and vengeful distraction, and the school board knows it. Unfortunately, three members of our school board are dishonest, uncaring and continue to permit him to hurt people, because they do not want to admit their own long-term selfishness, negligence and roles in facilitating and covering up abuse, which means innocent people continue to be hurt while these board members try to stave off their inevitable exposure.

We are asking you to take a closer look at Daniel D. Curry. If you do, you will see what a slap in the face the Superintendent of the Year award is to everyone who has been so badly impacted by him. This is a man who plots and schemes to destroy people's lives. He does not deserve the award, and we firmly believe it should be rescinded. If it isn't, and as our suits bring to light information which will garner significant media focus and attention, people will begin to question how he could have received such an award in spite of what he has been doing. Please, as the members of PSSAM who chose him for this award, read through it and see what you think. While we are sure the majority

of you care about everyone in your districts and do your best to run them as well as possible within the confines of what policy and funding permit, that has not been the case in Calvert County for years. We hope to hear about Daniel D. Curry being stripped of an honor he has *never* deserved, and which in his case isn't worth the pressed board to which the engraved plate is affixed. Maybe you can give it to a Superintendent who does actually deserve it.
